Obtaining a Refund on Sales/Use Tax Paid on Dental Prosthetics

Thanks to MDA lobbying, the state sales and use tax on purchases of dental prosthetics was repealed as of Dec. 28, 2017. Here's more good news: Dentists can now receive a refund for sales and use tax paid after July 1, 2017. According to the Michigan Department of Treasury, eligible dentists can receive their refund from the dental lab in which they purchased the prosthesis. Labs are responsible for refunding dentists for the paid tax, and the Treasury Department will refund the dental labs. This presentation will provide an overview of the scientific evidence for characteristics of the oral microbiome and the consequences for the rest of the body when its members travel and colonize remote locations. The evidence for links between periodontal disease and systemic diseases such as diabetes, cardiovascular disease, rheumatic arthritis, aspiration pneumonia, kidney disease, Alzheimer's disease and other cognitive decline, as well as pregnancy will be summarized along with the systemic effects of periodontal treatment.

Research designs and the strength of the evidence possible to derive from them will be briefly described. Moreover, the importance of using standard case definitions for periodontitis surveillance will be described.

COURSE OBJECTIVES

By the end of this course, participants will be able to:

- understand the fluctuating and diverse nature of human oral microbiome
- know the current guidelines for prophylactic use of antibiotics
- understand the systemic effects of antibiotics
- be familiar with the mechanisms underlying the oral-general health links
- understand the status of the current scientific evidence for the relationships between the health of the mouth and the rest of the body
- be familiar with the current evidence for the effect of periodontal treatment on various systemic diseases
- understand different research designs
- know the difference between "association" and "causality"
- appreciate why it is so difficult to demonstrate causality between oral and general health
- understand the importance of standard periodontitis case definitions

Speaker Bio:

Wenche ("Venke") Borgnakke DDS MPH PhD is a Senior Research Associate in the Department of Periodontics and Oral Medicine at University of Michigan School of Dentistry. She earned DDS and PhD degrees from the Royal Dental College in Copenhagen, Denmark, and a Master of Dental Public Health degree from the University of Michigan. Dr. Borgnakke has published 8 book chapters and about 70 papers; is a reviewer for 42 scientific journals; is Principal Investigator for an 8-year study funded by the ITI Foundation among persons with diabetes and end-stage periodontitis restored with overdentures; and has lectured nationally and internationally in Canada, Cuba, The Netherlands, Norway, Pakistan, Saudi Arabia, and The United Arab Emirates. The American Academy of Periodontology (AAP) awarded her a 2012 Special Merit Award and the Clinical Research Award in 2013 and 2016. Since its inception in 2005, Dr. Borgnakke has been a member of the CDC/AAP periodontitis surveillance workgroup whose clinical periodontitis case definitions increasingly are regarded the global standard. Dr. Borgnakke regards it a special honor to be first author on the only chapter on oral health and diabetes in the federal work "Diabetes in America."
