# WDDS Committee Updates

# Community Networking Committee (Bonita Neighbors):

Wayne Colquitt and I are on the Washtenaw County Oral health Task Force, which is lead by the county health department. We also serve on Washtenaw County Health Initiatives dental section. We are involved with an interdisciplinary group of healthcare safety net providers and administrators. We worked to prepare the county for impact of the affordable care act, as well as coordinated care between disciplines.

# Nomination Committee Update

#### Share in the Vision, Be an MDA Leader

The newly formed MDA House of Delegates Nominating Committee is seeking candidates for a variety of MDA Board, officer, and leadership positions to take office in 2015.

As a result of MDA governance changes approved earlier this year, the House of Delegates will now elect all members of the MDA Board of Trustees, MDA officer positions and ADA delegates and alternate delegates. MDA Delegates will cast votes for trustees from a list determined by the Nominating Committee. The nine candidates receiving the most votes will be elected. Additional votes will be taken for individual officer positions. The officer positions include MDA president-elect, secretary-treasurer, House speaker, and editor. The vice-president position was eliminated beginning in 2015. Therefore, an election was held in 2014 and the vice-president will succeed to president-elect in 2015. The position of president-elect will be open in 2016.

Beginning in 2015, the MDA Board of Trustees will be reduced

from 16 to nine trustee positions, plus six officers and the CEO/executive director.

The Nominating Committee is chaired by the MDA immediate past president, which is made up of 12 members selected from each of the MDA regions. Washtenaw is represented by past WDDS and MDA president, Joe Kolling. This year's chair is Dr. Norm Palm, of Grand Rapids.

To apply for a position on the MDA Board, interested candidates should submit an application, a current curriculum vitae and signed conflict of interest statement. The editor position has additional requirements. The deadline for submissions for the 2015 House is December 1, 2014.

#### AM Speaker Bio & Course Overview:

Marie T. Fluent, DDS is a graduate of the University of Michigan, School of Dentistry. She has enjoyed twenty five years of practice in Virginia, Maryland and Ann Arbor, Michigan. Dr. Fluent is on the advisory committee for the Washtenaw Community College Dental assisting program, and is a consultant for the Ann Arbor VA hospital. She is on the editorial board for THE DENTAL ADVISOR and lectures on the topics of dental materials and infection control in the dental office. Although disease transmission in the dental setting is rare, consequences may be severe, highly publicized and potentially lethal. This course will review CDC guidelines and OHSA recommendations and the supporting scientific literature. Participants will learn strategies to break the infection "chain of transmission" and prevent exposures to blood-borne pathogens and other infectious materials. The dental team will understand that the goal of infection prevention is to ensure a mutually safe practice environment for both employees and patients. Participants will learn that infection control is a team based responsibility requiring constant attention, education and compliance.

#### Course Overview:

"Stem cells hold the potential for tissue regeneration and have been used therapeutically in many fields of Medicine. The recent discovery of the existence of dental tissue stem cells has raised the possibility of

exploiting the regenerative potential of these cells to make new dentin, engineer a dental pulp, or rebuild periodontal tissues. In this seminar, we will discuss the state-of-the-art in the field of dental tissue regeneration with stem cells, and will present our vision for the future clinical use of stem cells in General Dentistry".
