Victors for Veterans: Serving Those Who Served

The Community-Based Clinical Education program at the University of Michigan School of Dentistry (UMSOD) has been recognized nationally as one of the best programs that combines treating underserved populations with the education of dental students.

In recent years, this program has evolved from just two external sites to over 32 sites under the leadership of Dr. Wilhelm Piskorowski, Assistant Dean for Community-Based Dental Education (CBDE), and Dr. Howard Hamerink, CBDE Academic Program Manager.



A major blessing of living in the United States of America is that we have the most dedicated, self-sacrificing men and women protecting our freedoms daily. Those who serve in our military put themselves in some of the most dangerous situations to defend our freedoms and protect our way of life.

Unfortunately, most U.S. veterans don't qualify for dental care provided by the VA health system. Realizing this problem with our veterans' access to care, former dental students at UMSOD suggested to Dr. Piskorowski that a program be started to help veterans here in Michigan. From that suggestion the Wolverine Patriot Project began in October 2012.

This year-long program proved a dental care model where free oral health care is provided in northern Michigan dental offices to veterans living at or below 200% of the poverty level.

The continued success of this program is due largely to the support and enthusiasm of local dentists and members of the Resort District Dental Society. They include Dr. Phillip

The Wolverine Patriot Project coordinated volunteer efforts from dental students, faculty, social workers, allied health care professionals, local dentists, assistants, and specialists to work as a team to provide comprehensive care.

The benefits have been significant. With this program, our predecessors demonstrated that for every dollar spent, five to seven dollars of donated care could be provided. We have built on the success of those efforts.

Since the summer of 2015, dental students and faculty at the University of Michigan School of Dentistry have teamed up to enhance the outreach initiative.

Our extension of this outreach initiative has taken the new name, Victors for Veterans. Our focus has been to continue to provide the quality care that began nearly four years ago, and to make it sustainable.

Victors for Veterans enlisted the support of others in northwestern Michigan to treat our veterans. Doctors Phillip C. Yancho and Dr. Wayne Olsen opened the doors of their practices for treatment on select weekends.

Since January of 2016, Victors for Veterans provided over \$200,000 worth of comprehensive dental care to about 50 veterans in need. This range of care included everything from cleanings and fillings to crowns and implants. Treatments improved the veterans' speaking, chewing, swallowing, appearance, and overall, their oral health-related quality of life.

We also want the new program to become a sustainable model to aid veterans in the future.

Victors for Veterans will continue to advance and sustain itself with select insurance coverage, product donations, gift funds, and, most importantly, the volunteer service of all professionals involved.



The continued success of this program is due largely to the support and enthusiasm of local dentists and members of the Resort District Dental Society. They include Dr. Phillip Yancho, Dr. Wayne Olsen, Dr. Ed Duski, Dr. Jan Duski, Dr. Bill Lee, Rene Louchart, RDH, and allied health professionals such as Tracy Sineway, MSW candidate, and Chuck Lerchen, AVSO. This is a bold example of interprofessional care.

Dr. Diana Ellis, co-mentor of the project, points out, "Part of the key to the program's sustainability is that the costs of the program are fairly low as we have student providers and local dentists donating their efforts to help. Donations from labs, representatives, and other organizations further strengthen the program."

This "start to finish" approach ensured treatment was consistent and ethical – a paramount example for dental students to learn firsthand.



"Being able to treat veterans who have served this country has been an incredible experience," said Jon Asimakopoulos, a former D4 who volunteered to provide treatment until he graduated in May. "These individuals," he added, "have made a remarkable sacrifice by serving. To hear their stories puts into perspective how special each veteran is. I feel fortunate to be a part of this project and look forward to seeing it continue to succeed in the future."

-Dr. Larry DeGroat is the president of the Michigan Dental Association, and practices dentistry in Bingham Farms, MI

-Laurie K. McCauley is the William K. and Mary Anne Najjar Professor and Dean of the School of Dentistry, and Professor in the Department of Pathology at the Medical School at the University of Michigan. Dr. McCauley earned her B.S., D.D.S., M.S. and Ph.D. (Veterinary Pathobiology) all from The Ohio State University. She has had several visiting scientist/professor appointments including the Institut de Genetique et de Biologie Moleculaire et Cellulaire, the École Normale Supérieure de Lyon, and the Center for Experimental Therapeutics and Reperfusion Injury, Brigham and Women's Hospital, Harvard Medical School. Dr. McCauley is a diplomate of the American Board of Periodontology, a fellow in the American Association for the Advancement of Science, a former council member of the American Society for Bone and Mineral Research (ASBMR), former Associate Editor of the Journal of Bone and Mineral Research (JBMR), a Fellow in the American College of Dentists and the International College of Dentists, and also served on the National Institutes of Health, National Advisory Dental & Craniofacial Research Council. For more than twenty years.

Dr. McCauley has led an active research program in hormonal controls of bone remodeling, parathyroid hormone anabolic actions in bone, and prostate cancer skeletal metastasis. Among her many recognitions are the inaugural Paula Stern Achievement award from the ASBMR, a distinguished scientist award from the International Association for Dental Research, The Ohio State College of Dentistry Distinguished Alumnus award, and membership in the National Academy of Medicine.
