Peer Review Update

As Chair of our Peer Review Committee, I attended the MDA workshop during the Annual meeting in Grand Rapids. It was insightful, and I would like to pass along some information. First of all, peer review is a benefit of your membership, and as members we have all agreed to cooperate in its actions.

Non-members are not afforded this service. As stated by the MDA the need for peer review has decreased markedly over the last few years...so that's great. By far the biggest action that leads a patient to start the process is COMMUNICATION. They are unable to speak with the doctor about a concern and are blocked by "well meaning" staff from getting through or you don't call them. Unfortunately this is how they know that they will get through to you and have your attention..

In short peer review has two phases the first is mediation. I or a member of our committee will call the patient and listen to their side of

the story and see what could resolve this for them; we then call the you and get your side, explain what the patient is concerned about and what could resolve it for them. At this time they may agree or counter with another resolution, we mediate between the parties and try and seek agreement, and resolution. At any time ether party may ask for a review, a more formal procedure, where three members of the committee will meet, interview and do a clinical review of the patient concern. We then will interview you. The members will deliberate and a consensus report will be written and sent back to the MDA. If you disagree you have the right to have your case reviewed at the state level. Remember this is not a legal procedure, the results are not reported to the National Data Bank. NOTE: This class covers the state's required one-hour credit for pain management.

In the morning session the speaker will discuss the changing antibiotic options in dentistry for acute infections and prophylaxis for old and new antibiotic categories and formulations. The current American Heart Association at-risk patients and the inconsistencies for the ADA/Orthopedic Surgeons 2014 recommendations will be discussed. What is recommended for patients already on, or recently on, an antibiotic? New data and designs dictate a new approach to cardiac and vascular stents. What is the bottom line on prophylaxis for vascular repairs, the four approaches to renal dialysis, IVC filters, Hickman catheters, portacaths and the VA vs. VP hydrocephalus shunt What medical conditions will affect antibiotic selections?

In the afternoon the speaker will cover how the dentist is faced with an aging population with a myriad of medical problems and physician-prescribed medications. Medical problems like diabetes mellitus, hypertension therapy, anticoagulant therapy and the drugs for a myriad of cardiovascular diseases directly affect dental treatment-planning and prescriptions written by the dentist. This course will provide the dentist with a framework for choosing antibiotics, analgesics, local anesthetics and other top-50 dental prescriptions in the context of potential drug-drug interactions and disease-related complications of the medically compromised patient.

Dr. Fazio is associate clinical professor of surgery at Yale University School of Medicine.

<u>Speaker Bio:</u>

Jacques is the Donald A. Kerr Endowed Professor of Dentistry (Dept. of Cariology, Restorative Sciences and Endodontics), Professor of Otolaryngology (Medical School)and Professor of Biomedical Engineering (College of Engineering) at the University of Michigan. He is the Co-Director of the University of Michigan Head and Neck SPORE grant funded by the National Cancer Institute (NCI), has served as a member of National Institutes of Health (NIH) study sections, and has been the principle investigator for several NIH grants. Jacques is an elected Fellow of the American Association for the Advancement of Sciences (AAAS), and recently received the Distinguished Scientist Award from International Association for Dental Research (IADR). He is currently the President of the Michigan Section of the American Association for Dental Research (AADR). Jacques is Associate Editor of the Journal of Dental Research and a member of the editorial board of several journals, including the Journal of Endodontics, Operative Dentistry, and Stem Cells in Oral Medicine. His research interests are in angiogenesis and in stem cell biology. His current research foci are the study of the pathobiology of stem cells and endothelial cells in head and neck tumors, and the study of dental pulp stem cell differentiation in the context of dental tissue engineering.

Course Overview:

"Stem cells hold the potential for tissue regeneration and have been used therapeutically in many fields of Medicine. The recent discovery of the existence of dental tissue stem cells has raised the possibility of

exploiting the regenerative potential of these cells to make new dentin, engineer a dental pulp, or rebuild periodontal tissues. In this seminar, we will discuss the state-of-the-art in the field of dental tissue regeneration with stem cells, and will present our vision for the future clinical use of stem cells in General Dentistry".

Report from the MDA House of Delegates

At the May MDA House of Delegates meeting in Grand Rapids, seven of -Create a House of Delegates Bylaws Committee. our member Delegates, and Trustees participated and approved major changes in the association's governance. Changes are designed to improve operational efficiency expertise and responsiveness. These include:

-Make the MDA Board of Trustees the governing body of the association, with the House serving in an elective and representative capacity:

-Reduce the number of trustee positions from 17 to 9 and made them all at-large positions, no longer elected by trustee districts but instead by the House itself.

-Create a House nominating committee to select all candidates for MDA officers, MDA trustees, Delegates/alternates to the ADA meeting and the ADA 9th District Trustee.

-Combine the secretary and treasure officer positions on the Board.

-Eliminate the vice-president officer position.

-Give the House and Board the authority to suspend or remove Board members.

-Give the Board the authority to form an Executive Committee as needed, to be comprised of the association's officers.
