Positions Open on Michigan Board of Dentistry

Each year the MDA Board of Trustees makes recommendations to the governor for individuals to serve on the Michigan Board of Dentistry. One general dentist and one specialty certification position will open on the Board in June 2022.

If you are interested in submitting your name for MDA endorsement, forward a letter of interest and a current curricula vitae (no longer than two pages) to the MDA prior to Feb. 1, 2022, to Michelle Cruz via email at mcruz@michigandental.org, or fax her at 517-372-0008.

Candidates will be reviewed by the MDA Board of Trustees at its March 4, 2022, meeting. MDA trustees will approve two endorsements for each open position. The names and CVs of the individuals endorsed by the Board will then be forwarded to the governor for consideration. MDA endorsement is not required to be considered for service on the Board of Dentistry.

DDS Program Reaches \$25 Million in Donated Services

The Michigan Donated Dental Services (DDS) Program recently reached a new milestone -- \$25 million in donated treatment since its inception in 1995. The program serves indigent, elderly, or disabled Michigan residents who cannot obtain dental treatment through other programs or services.

More than 400 MDA members serve as DDS Program dentists, and 190 dental laboratories are active in the program. To date, the DDS Program has provided care to more than 6,800 individuals.

The DDS Program is administered by the MDA with funding from the Michigan Department of Health and Human Services. The program is a licensee of the Dental Lifeline Network. Services provided include extractions, oral surgery, and dentures.

"Serving as a DDS volunteer is rewarding and a wonderful way to help some of our most disadvantaged citizens," says April Stopcynzki, MDA manager of access and prevention who oversees the program. "Most DDS volunteers treat just one or two patients each year, in their offices. Patients are extremely grateful for the care they receive."
